SHOW RULES

APHC RULES WILL APPLY TO ALL CLASSES ACCORDING TO THE 2010 APHC RULE BOOK.

1. ENTRY DEADLINE---JULY 12, 2010. ENTRIES MUST BE FAXED TO (780) 922-3391. EXHIBITORS ARE RESPONSIBLE FOR ALL ERRORS ON ALL ENTRY FORMS.
2. CATTLE ENTRIES MUST BE RECEIVED BY FAX BY JULY 5, 2010. NO POST ENTRIES ALLOWED IN THE CATTLE CLASSES.
3. HORSES ALREADY ENTERED IN THE SHOW MAY ENTER ADDITIONAL CLASSES WITHOUT PAYING THE POST ENTRY CHARGE.
4. A \$50 NSF CHARGE WILL BE CHARGED ON ALL CHEQUES NOT HONORED AND A FAILURE TO CLEAR UP THE DEBT PROMPTLY MAY RESULT IN SUSPENSION FROM THE APHC.
5. ALL HORSE ARE SUBJECT TO DRUG TESTING AND ALL OWNERS AGREE THAT BY MAKING THEIR ENTRY, THEY WILL ALLOW THEIR HORSES TO BE TESTED.
6. REGISTRATION PAPERS: ORIGINAL PAPERS OR CURRENT PHOTOCOPY OF FRONT AND BACK MUST BE PRESENTED WITH ALL ENTRIES. MASTER REGISTRATION FORMS MUST SHOW OWNER EXACTLY AS LISTED ON THE PAPERS. NON-PRO AND YOUTH EXHIBITORS MUST PRODUCE REGISTRATION PAPERS SHOWING OWNERSHIP OR PROVING APPROVED RELATIONSHIP TO THE OWNER.
7. MEMBERSHIP REQUIREMENTS: EVERY PERSON COMPETING IN AN AHAA APPROVED SHOW MUST POSSESS A CURRENT AHAA MEMBERSHIP FOR THEIR POINTS TO COUNT FOR THE AHAA YEAR END AWARDS. IF THE EXHIBITOR WISHES TO ENTER THE APHC APPROVED CLASSES, THEY MUST POSSESS A CURRENT APHC MEMBERSHIP CARD. APPLICATIONS FOR MEMBERSHIP MAY BE MADE AT THE SHOW, BUT MUST BE COMPLETED BEFORE ENTERING THE FIRST CLASS.
8. EXHIBITOR NUMBERS: EACH HORSE WILL BE ISSUED AN EXHIBITOR NUMBER AT THE SHOW AND MUST WEAR THAT NUMBER DURING THEIR CLASS. IF THEY ARE IN A PERFORMANCE CLASS THE NUMBERS MUST BE VISIBLE ON BOTH SIDES OF THE SADDLE PAD OR THE EXHIBITOR WILL BE DISQUALIFIED. IN HALTER CLASSES, THE NUMBER MUST BE WORN ON THE EXHIBITOR'S BACK.
9. UNSPORTSMANLIKE CONDUCT: WHEN AN EXHIBITOR, OWNER AND/OR HIS REPRESENTATIVE ACTING ON BEHALF OF THE EXHIBITOR IS GUILTY OF UNSPORTSMANLIKE CONDUCT AND/OR INHUMANE TREATMENT OF A HORSE WHILE ON THE SHOW GROUNDS, THE SHOW MANAGEMENT, AT ITS SOLE DISCRETION, MAY SUSPEND SUCH INDIVIDUAL(S) FROM COMPETITION AND A REPORT WILL BE FORWARDED TO THE APHC. NO REFUND IN ENTRY FEES WILL BE MADE.

10. AT THE DISCRETION OF THE SHOW MANAGEMENT, IF THERE IS ONLY ONE ENTRY IN A PERFORMANCE CLASS, THE CLASS MAY BE CANCELLED OR COMBINED WITH ANOTHER CLASS.
11. HIGH POINT AWARDS: IN ORDER TO QUALIFY FOR A HIGH POINT AWARD THE EXHIBITORS MUST SHOW TO ALL JUDGES. POINTS WILL BE TABULATED THROUGHOUT THE SHOW. POINTS ARE AWARDED USING THE "POINTS PER HORSES SHOWN METHOD." FOR EXAMPLE 1ST PLACE OUT OF 6 ENTRIES WILL RECEIVE 6 POINTS, 2ND WILL RECEIVE 5 POINTS, 3RD WILL RECEIVE 4 POINTS AND SO FORTH. TIES WILL BE DECIDED BY THE PARTICIPANT WITH THE MOST 1ST PLACE AWARDS.
12. CLASSES ELIGIBLE FOR EACH HIGH POINT DIVISION:
 - JUNIOR HORSE (CLASSES 36,38,42,43,55,57,58,70,73,79)
 - SENIOR HORSE (CLASSES 37,46,55,61,71,74,79)
 - NON-PRO (CLASSES 6,12,20,22,26,30,32,34,39A,48,51,63,66,72,76)
 - NOVICE NON-PRO (CLASSES 6,12,20,22,25,30,32,34,39,47,50,62,65,72,75)
 - YOUTH (CLASSES 13,21,29,36A,49,54,64,69,78)
 - NOVICE YOUTH (CLASSES 13,21,28,45,53,60,68,78)
 - WALK/TROT YOUTH (CLASSES 13,21,27,44,52,59,67,77)
 - HALTER HORSE (1,2,3,4,5,7,8,9,10,11,14,15,16,17,18,19,23,31,33,35)
 - CATTLE HORSE (80, 81, ,83,84, 87)
 - ALL-BREED (CLASSES 101,102,103,104,105,106,109,110,112,114,116,118,119)
 - ALL-BREED YOUTH (CLASSES 103,104,105,106,108,110,111,113,115,117,119)

IN ORDER TO QUALIFY FOR A HIGH POINT AWARD, THE HORSE MUST BE COMPETE IN MORE THAN ONE CLASS IN ITS' DIVISION.

13. **PLEASE BE ADVISED THAT THERE IS NO WASH RACK ON THE GROUNDS AND THAT NO FEED IS ALLOWED IN THE ARENA AT ANY TIME.**
14. **EXTREMELY LIMITED STABLING IS AVAILABLE ON SITE, THEREFORE WE ARE TRYING TO OBTAIN STABLING AT NEARBY FACILITIES. IF YOU NEED STALLS PLEASE CALL LAURIE KNOX @ (780) 922-3391.
